VOLUNTARY ANNOUNCEMENT LATEST DEVELOPMENT OF SHANGHAI HAICHANG POLAR OCEAN PARK

Reference is made to the announcement of Haichang Ocean Park Holdings Ltd. dated 18 January 2015 (the “**Announcement**”), in which its board of directors announced, among other things, that 上海海昌極地海洋世界有限公司 (Shanghai Haichang Polar Ocean World Co., Ltd.*) won the bids of the land use rights on 16 January 2015 in respect of certain land plots in Shanghai, the PRC, for the development of the park portion of Shanghai Haichang Polar Ocean Park. Unless otherwise defined in this announcement, the capitalized terms shall have the same meaning as those stipulated in the Announcement.

This announcement is made by the Company on a voluntary basis. The purpose of this announcement is to keep the Shareholders and potential investors of the Company informed of the latest business development of the Group, in particular, Shanghai Haichang Polar Ocean Park.

THE LAND PLOTS AND SHANGHAI HAICHANG POLAR OCEAN PARK

The Board is pleased to announce that on 16 September 2015, the project for Shanghai Haichang Polar Ocean Park, after obtained the approval for environment impact assessment on 13 July 2015, obtained the “Approval of Shanghai Haichang Polar Ocean Park Project” issued by 上海市發展和改革委員會 (Shanghai Development and Reform Committee*) and the project for Shanghai Haichang Polar Ocean Park was formally approved. Shanghai Development and Reform Committee, being the governmental body in Shanghai, the PRC, is the authority responsible for, among other things, the administration and approval of substantial development projects in Shanghai, the PRC. With the above approval, it is expected that the project planning and design proposals will also be approved by 上海市臨港地區開發建設管理委員會 (Development and Construction Management Committee of Lingang New City of Shanghai*) soon.

The Board considers that by obtaining the above project approval and design proposals approval, the project for Shanghai Haichang Polar Ocean Park has achieved another milestone and such approvals have provided the prerequisites for subsequent construction application. It is expected that the construction of the project will commence in full swing in October 2015.

The Group will continue to cooperate and coordinate closely with the relevant government authorities in the PRC in order to ensure the development project of Shanghai Haichang Polar Ocean Park will proceed efficiently.

Further announcement(s) will be made by the Company in connection with the development of Shanghai Haichang Polar Ocean Park as and when appropriate.
